- II. Read and approved minutes of April 20th meeting: approved as written
- III. **Pastor's Report:**
Connie Crabtree passed. On 5/20/21 the Kitchen Angels will meet to remember her and to decide where to make a gift in her name. Groups are being setup Community Church builder. Community Meal will begin again the second Friday in June. There will be a temperature check and the volunteers will wear KN95 masks, and attendees will also be provided masks. Cindy Lash will be opening the Clothes Closet. You must have a covid-19 vaccine in order to volunteer. There will be social distancing and take out will be available. - IV. **Treasurer's Report:**
A written preliminary Income and Expense Summary Report for April 2021 was submitted. Income of \$29,619 expense of \$26,178 MTD surplus \$3,441 and FYTD deficit of \$13,808 was presented.
